






GardaGloss Art

► Origin of raw materials used for the production of our paper:

Raw materials certified with FSC chain of custody

FSC controlled wood certified virgin fibres

Figures from 01/01/2010 to 31/12/2010 - as a total for all our products:

Cartiere del Garda uses both ECF and TCF pulp in the manufacture of its products.

According to paper industry BREF, ECF and TCF are considered as having the same environmental value.
